David Barrett Joins the Forestry Hall of Fame



Beaver Banker David Barrett's passion for the woods leads him to the Forest Hall of Fame. The Registered Professional Forester Association of Nova Scotia and the NS Forest Technicians Association surprised David with the honour recently at their annual meeting in Truro.

Downy Thompson introduced David saying "It was apparent to me from the very first meetings I attended with David that he has passion for the woods and he would later prove to me that in many ways he is also a visionary. He is never afraid to stick up for his beliefs and I have always respected him for that. David's contributions to the forest industry over the years are undeniable but aside from that, he is also recognized as being an involved, contributing community member, whose generosity is well known

In his response David repeatedly referred to the word "Lucky". Lucky is how he feels about spending his life doing what he loves best. He

expressed how lucky he feels to have worked side by side with his father for thirty-two years and lucky to have his wife support him in his work for over fifty years. He feels privileged to have worked with many distinguished individuals who made a difference in the forestry industry of Nova Scotia. To name a few Dr. Wilfred Creighton, and Laurie Ledwidge.

David also worked in forestry for many years with Jimmy Wilber in particular, to establish the N.S. Forest Products Road Access Rebate Program and to encourage the N.S. and Federal Sales Tax Departments to treat the Nova Scotia Forestry Industry fairly. He served as Chair of the N.S. Forest Products Association Sawmill Chip Committee and he still continues to be a member of many forestry and community related organizations.

On the home scene he has worked to involve others with the woods and is a firm believer in encouraging groups and

organizations that expose our youth to forestry. He has worked with the local Scouts on the tree planting programs and the You-Pick Christmas lot in Beaver Bank.

He is known for his calls to our local councillors, Mayor and other officials as well as his open letters to the Premier and MLAs of N.S. For over fifty years he has presented matters of interest to forestry and community before The Nova Scotia Legislature Law Amendments Committee.

David wanted to leave us with one thought, "Stand up for your convictions, make them publicly known. You will be pleasantly surprised how you can influence both public policy and laws in Nova Scotia". Congratulations David. We hope you have many more years enjoying what you love.

Volunteer Recognition Awards – Waverley-Fall River-Beaver Bank

The Beaver Bank Kinsac Community Centre will be host to the 11th Annual Waverley-Fall River-Beaver Bank Volunteer Recognition Banquet on April 25, 2014. An anticipated crowd of 80 guests will gather to congratulate 24 well deserving community volunteers from a variety of organizations. One volunteer from each of the categories (Adult and Youth) will be presented with the volunteer of the year award for 2013. The dedication and hard work of all of our volunteers in our communities is appreciated and valued.

Lyme Disease – Prevention and Control

It is important that you protect yourself and your family whenever you enjoy the outdoors – especially in grassy, wooded or shrub covered areas. Blacklegged ticks (also called the deer tick) can be found across the province and can carry the bacteria that causes Lyme disease.

Lyme disease is a bacterial infection transmitted to humans and pets by a bite from a Blacklegged tick. To prevent Lyme disease:

1. PROTECT yourself with insect repellent, cover your skin, and walk on well-traveled paths.
2. CHECK yourself, your children, and your pets after walking in wooded or grassy areas.
3. REMOVE ticks as soon as you find them.
4. RECORD the date and location of the tick bite and contact your doctor promptly if a rash or flu-like

symptoms appear. The first symptom of Lyme disease is a rash near the tick bite that may look like a bull's eye target. The rash appears between 3 and 30 days (usually 7 – 10) and you may also develop flu-like symptoms.

Landscaping techniques and yard maintenance will reduce the number of Blacklegged ticks around your home. For more information on Lyme disease, visit the Health and Wellness website at www.gov.ns.ca/hpp/cdpc/lyme.asp, or call your local Public Health Services office, 902-481-5800.

Brush Burning Restrictions – The Rules and Dates Have Changed

The new wildfire-risk season, when domestic brush-burning is restricted, began March 15. You no longer need a permit but you must check an online burning restrictions map to learn when it is ok to burn brush for your area. The map can be found at www.novascotia.ca/burnsafe. The map will show green, red, or yellow in each county, to let Nova Scotians know when it is safe to burn. The same information is available in a recorded message by calling 1-855-564-2876.

Agencies, Board and Commissions – Spring Recruitment Campaign

Nova Scotians wanting to make a difference in their communities can now apply for the many available positions on the province's 165 agencies, boards and commissions.

The province launched its spring recruitment campaign, April 11th, to get more people to play an active role. Applications for non-adjudicative agencies, boards and commissions are welcome anytime, with assessment of applications to begin on May 12th. The application deadline for adjudicative agencies, boards and commissions is May 19th. Increased Loans to Small Businesses – Improvements to the Provincial Guarantee on Loans

Nova Scotia's small businesses will have better access to loans through improvements to the Credit Union Small Business Loan Guarantee Program. Premier Stephen McNeil announced, April 14th, government will keep its promise to increase the provincial guarantee on term loans from 75 per cent to 90 per cent. The total available to lend will increase from 25-million dollars to 50-million.

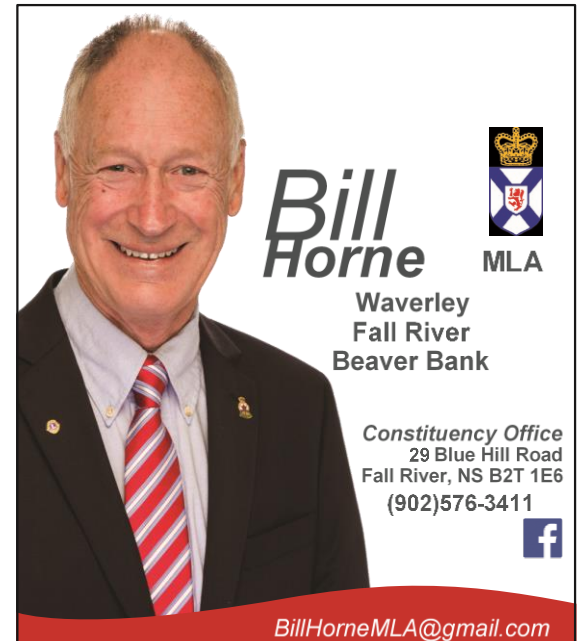
The maximum loan guarantee for social enterprises is also increasing from 150-thousand dollars to 500-thousand dollars. Premier McNeil says Nova Scotia entrepreneurs need access to capital to expand, hire new workers, and reinvest in their communities. Over the past 10 years, credit unions have approved loans worth 56-million dollars, helping more than 12-hundred small businesses. Loans are available throughout the province. MP News and Views

It is with great sadness that we learned of Hon. Jim Flaherty's sudden death. New Democrats have offered our most sincere condolences to his family and colleagues in this difficult time. Flaherty served as the federal Minister of Finance for eight years and was a Member of the Provincial Parliament (MPP) in Ontario. Mr. Flaherty served his country with dedication. He will be missed.

I have also extended my condolences to the family and friends of Noel Knockwood who recently passed away. Mr. Knockwood was a highly respected Mi'kmaq elder and spiritual leader. He was the first aboriginal Sergeant-at-Arms at the Nova Scotia Legislature, a veteran of the Korean War and a member of the Mi'kmaq Grand Council. I was very honoured to work with Mr. Knockwood on a commemorative monument that honours Canadian service men and women who gave

their lives in the Liberation of the Netherlands. The monument is located at Pier 21 in Halifax and commemorates these men and women in four languages - English, French, Dutch, and Mi'kmaq.

Health Accord Expiry

Many residents have expressed their disappointment with the current government's failure to negotiate a new Health Accord with the provinces and territories. We believe there is a strong

federal role for the provision of public health care including an adequate and stable funding formula for the Canada Health Transfer. The federal government must also work with the provinces to create health care reforms including home care, wait-times, a prescription drug plan, and ensure that the quality and standard of health care is guaranteed across the country.

Passenger Rail Service in Atlantic Canada at Risk

In an earlier column, I wrote about how Atlantic Canada is at risk of losing its passenger rail service. At issue is the loss of a section of track between Miramichi and Bathurst in New Brunswick. Canadian National (CN) wants to sell or abandon this stretch of track as they no longer use the line to transport freight. Via Rail uses this line for its passenger service but without federal government investment in this stretch of rail line, passenger VIA rail service is at risk. Over 25,000 residents have signed a petition asking the federal government to invest in this line. As well, the Province of New Brunswick has agreed to some financial assistance to help maintain freight service to northern New Brunswick.

I recently travelled to Ottawa by train along with my MP colleagues Megan Leslie, Robert Chisholm, Yvon Godin and Philip Toone. Many supporters joined us at train stations along the way to show their support in maintaining passenger rail service.

NDP Introduce bill to Extend Retroactivity of CPP Survivor Benefits

In February, my colleague Olivia Chow introduced a bill to abolish deadlines that restrict retroactive payments of CPP survivor benefits to just 11 months. Many widows and widowers are losing CPP survivor pension benefits because of these arbitrary rules. Olivia introduced this legislation when a constituent in her riding was denied two years' worth of retroactive payments because she missed the application deadline while grieving the loss of her husband to cancer. The bill is supported by CARP—Canada's largest advocacy group for people over 50. CARP is in full support of removing this unfair rule that limits the time for people to apply for their CPP benefits. Allowing survivors to receive their partner's pensions is a matter of fairness and dignity.

Social Contract Exists between Veterans and the Government

In recently released legal statements for a veterans' class action lawsuit in British Columbia, the government is denying that a social contract exists between the federal government and veterans. It is wrong to say that the federal government has no social contract or covenant with its veterans. The federal government has a moral,

social, legal, and fiduciary responsibility for the men and women who serve. Reference to the government's social contract is included in most veterans' legislation that outlines benefits and services for veterans and their families.

I have urged the federal government to settle with the veterans' who have launched this class action lawsuit rather than fight them in court. The lawsuit launched by Equitas Society is seeking fair compensation for injured veterans under the New Veterans Charter.

In other news, I am pleased that the federal government has reached a proposed settlement over the clawback of RCMP disability pensions. As you may recall, RCMP veterans had launched a class action lawsuit over the unjust clawback of their disability pensions. The proposed settlement will assist about 1,000 disabled veterans whose long-term disability benefits were reduced by the amount of their Veterans Affairs disability pension.

North Beaver Bank Wind Project Update

As we had explained in our last project update, Scotian Wind has been awarded a Community Feed-In Tariff approval from the provincial government to work on a proposal for a 4 turbine (8 MW) project in North Beaver Bank. The Nova Scotia Community Feed-In Tariff, or COMFIT, is designed for locally-based renewable electricity projects.

Since our last update in December, we held a public lunch and learn session at the Beaver Bank Kinsac Community Centre on Wednesday January 15. Over the lunch hour that day, Project Coordinator Stephen Thomas and I conducted a learning session about our wind energy project and the renewable energy program in Nova Scotia. The idea of the session was to give folks an opportunity to drop in on their lunch hour and listen to us speak

and ask questions afterward. A dozen or so folks showed up and we had a productive session with a lively round of Question and Answer. People had many interesting questions such as wanting to learn more about local benefits to the community and some of the environmental impacts of the turbines' location. An environmental assessment has been approved and can be accessed at this site.

On the construction side of things, the crew have been busy producing and submitting designs regarding the routes for roads and erosion

control. The tree clearing for roads has been completed. The digging required to put the bases in will not begin until much later in the year when the land completely dries up. Construction will not fully swing into gear until the fall and we expect the turbines would be delivered and installed in November. But these are only plans and many variables such as the weather can push that schedule back.

How can you Protect your Home from Wild Land Fires?

Over the past few years there have been a lot of wild land fires across our region (HRM). Some of these fires have caused millions of dollars in damage and that doesn't count the many thousands of dollars that it cost to fight them. The last two major fires that happened in HRM there were homes lost.

Did you know that homes can be lost even with the fire not coming close to the structure? Why? This question can be answered at a **"How to Protect your home from Wildland Fires" session that will take place on May 20th at the Beaver Bank Kinsac Community Centre**. At this session the Department of Natural Resources (DNR) will give you the information you need to prevent or reduce the risk of you losing your home in one of these fires. News from Station 48

For the months of March and April your Fire Dept. has responded to 17 calls. They consisted of: 1 propane leak, 1 alarm activated, 2 structure fires, and 13 medical assists. This brings our total for the year to 44. Once again medical assists make up the majority of our calls.

After a long winter the spring time weather is finally here but with the milder spring weather we are also into brush fire season. Springtime, before the forests green up, can be some of the most active times for brush fires so please practice responsible burning.

As most of you have probably heard the Department of Natural Resources has changed the fire regulations where you will no longer require a DNR permit if you plan to have an open fire. The new DNR fire season runs from March 15 to October 15. If you want to burn you will need to go to the Department of Natural Resources website and check the fire map. The map is updated every day at 2:00pm and all the information you will require regarding when or if you can burn can be found there.

As for the HRM open air-burning bylaw that has not changed. The HRM burning regulations still run from April 15 to October 15 and do not allow for open air burning for properties with both water and sewer services, however you can use a device such as a chiminea as long as all of the rules and regulations are followed. Please visit Halifax.ca and follow the links for all of the HRM information you will require regarding open air burning.

If you still have questions regarding where and when you can burn drop down to the fire hall any Tuesday night between 7:00pm and 8:00pm and we will be happy to explain it.

In closing I want to remind people the importance of having your house number visible from the street. When you drive through the Beaver Bank Kinsac area take notice of how many houses there are that you cannot see their house number. Some are due to the distance the house is from the street and some are due to the

house number too closely matching the colour of the house. The best place to have your house number is at the end of your driveway.

Remember if we can't find you we can't help you!

Goodbye for now and I hope to see you all at the Town Hall Meeting in May.

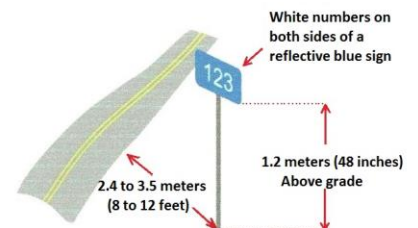
